Tournament Rules

1. **All bowlers must report 30 minutes before starting time. Time and lane assignments will be scheduled by the Tournament Committee and posted in advance.**
2. **ELIGIBILITY:** This tournament is open to all current and retired members of the military/DoD/State Employees (who support a military unit) and any Veteran and their family members and/or significant other. In order for a team to be legal, there must be at least two authorized participants on the team; and for a team of doubles to be legal, there must be at least one authorized participant on the team. All bowlers must be a current USBC member. Bowlers who are not members may qualify for entry and all USBC services by paying an Affiliate Membership Fee prior to bowling (Rule 301b). Non-members may also qualify by paying a one-time participation fee of USBC member (\$5.00) which only allows the bowler to enter the tournament, but will not qualify them for any USBC awards.
3. **ENTRY:** All teams must consist of four bowlers. Bowlers entered in Doubles event must also enter Singles and vice versa. Singles will be scheduled to follow Doubles automatically. Team and Doubles line-up must be arranged on the entry form. No rearranging of line-up after submission of entry form is allowed.
4. **MULTIPLE PARTICIPATION:** An individual may bowl in the Team and Singles event once. An individual's score may count in the Doubles event twice if it is to fill a last minutes cancellation. It must be approved by the Tournament Committee in advance of the event, and must be on the same squad being bowled. The individual may cash only once in this event. USBC Rule 317 states that "each participant may enter only once", except as noted in this rule.
5. **AVERAGE:** Report and use averages from USBC leagues only. Use highest USBC sanctioned average of 21 games for previous season (2014/2015). If current 21 game average as of 31 Dec 2015 is 10 or more pins above last season's average, current average must be used. If no average last season, use highest current USBC sanctioned average as of 31 Dec 2014 of 21 games or more. If there is no previous or current season average, bowler will use season-ending average for 2013-2014 of 21 games or more (fall and winter averages will be used). However, if the only USBC average (minimum of 21 games in a USBC sanctioned league) is from a summer league that was bowled in 2015, that average can be accepted. Any entrants without an established average must bowl with a scratch 200 average.

Bowlers are responsible for verifying their own average, whether submitted by the bowler, the Team Captain or others. If the submitted average is lower than required and results in a lower classification or more handicap, the bowler's score is disqualified and forfeits all prize winnings. If the submitted average is higher than required, prize winnings will be based on the submitted average. The re-rating rule (USBC 319c) will apply.
6. **HANDICAP:** Handicap will be based on 90% of the difference of the entering average. The entering average will be based on 230 for the tournament.
7. **PRIZES:** (a) All fees must accompany entry form; (b) Prizes will be paid with a ratio of 1:8 for Team event; 1:5 for Doubles event; 1:5 for Singles event; and 1:4 for All Events.
8. **FEES:** All fees must accompany the entry form and be received prior to closing date of entries (8 Jan 2016). Refund requests will be honored if written request is received by the closing date of entries.
9. **ALL EVENTS:** Entry in ALL EVENTS is optional. To qualify, a bowler must enter Team, Doubles, and Singles events. ALL EVENTS will be the sum of the three-event series with handicap.
10. **REFUNDS:** There will be no refunds after the closing date for entries; midnight, 15 Jan 2016 (MST).
11. **PREVIOUS PRIZE WINNERS:** Rule 319d will not apply.
12. **AVERAGE ADJUSTMENT FOR ENTRY:** Rule 319e will be waived.
13. **TROPHIES:** Individual trophies/plaques (or equivalent) will be presented to all 1st Place Winners.
14. **Hawaii:** Don't forget the Team Trophy!!
15. **ADDITIONAL RULES:** Tournament rules and guidelines not stated herein will defer to USBC Tournament rules. Tournament Director has final ruling decision on all disputes, complaints, or protests involving USBC or tournament rules.
